

“N26 Partner Subscriptions” Offer Terms for Access to Babbel

(Version 1.0, Date: 03.09.2026)

1. Subject Matter and Applicability

These Partner Offer Terms govern the specific terms for the Partner Subscription Access to Babbel (Babbel GmbH) as part of the N26 Partner Subscriptions feature. Unless otherwise specified herein, the general Terms and Conditions “N26 Partner Subscriptions”, including all definitions contained therein, shall apply. In the event of any conflict between these Offer Terms and the general Terms and Conditions “N26 Partner Subscriptions”, the provisions set forth in these Offer Terms shall prevail.

2. Access to the Partner Subscription

2.1

This offer is available to you if you are an N26 Standard or Premium customer in Germany, Austria, France, Spain or the Netherlands with an active, non-terminated, and unrestricted N26 bank account, are at least 18 years of age, and are acting as a non-professional.

2.2

You can purchase and manage access to the Babbel subscription, as specified in Clause 3, via the dedicated Partner Subscriptions section in the N26 App. Once you successfully complete the purchase, we will provide a unique Partner URL in the Partner Subscription section of the App, which you must use to set up or link your Babbel account.

2.3

If you have an active, paid subscription directly with Babbel, it will continue alongside your new N26 Partner Subscription Access. Babbel does not support automatic pausing, termination, or migration of existing payments and subscriptions. To avoid maintaining two separate paid subscriptions, you need to cancel your existing one manually directly with Babbel; otherwise, you may continue to use both independently.

3. Subscription Variant and Pricing

The conditions for your Partner Subscription Access depend on your specific N26 membership plan. All listed prices include statutory value-added tax (VAT); should the VAT rate change, prices will be adjusted automatically to reflect the applicable rate.
