### **Eligibility**

The promotion is available to existing and active N26 Business and Personal Standard, Smart, Go and Metal customers with their residence in Germany, France, Austria, Spain, Ireland, Belgium, Netherlands, Greece, Portugal, Luxembourg, Estonia, Finland, Slovakia, Slovenia, Lithuania, Latvia, Poland, Switzerland, Sweden, Norway, Denmark, Island, Liechtenstein, who receive an info card, email or push notification by N26, informing them about the promotion and their eligibility (hereinafter: 'Eligible Customer'). Eligible Customers who complete KYC after 10.11.2025 will need to first order and activate a N26 Mastercard Debit Card.

#### **Participation**

Eligible Customers will be required to update their N26 App to the latest version in order to participate and view the promotion progress in their N26 App. The Eligible Customer can participate in the promotion by clicking on the info card, email or push notification informing them about their eligibility and clicking 'Sign up now' on the in-app landing page for the promotion during the Promotion Period.

#### **Qualifying Transactions and Prize Draw**

A total of 100 Eligible Customers will be randomly selected (randomized between N26 Personal and Business Customers) to win back their qualifying spendings in card transactions with their N26 Mastercard Debit or N26 Maestro Debit ('Qualifying Transaction') during the Promotion Period, multiplied by a multiplier as further defined below ('Prize'). Qualifying Transactions are transactions from promotion enrollment to promotion end date. The multiplier is increased by +1 on every €500 spent during the Promotion Period. ATM withdrawals, transactions to credit accounts (e.g. account top-ups at other banks), betting and casino gambling transactions, cash-like (quasi-cash) transactions such as money or cryptocurrency purchases do not qualify for the promotion.

## **Miscellaneous**
